Source Water Assessment

Rend Lake is utilized by the Rend Lake Inter-city Water System (Facility # 0555100) to provide water to 67 communities in Williamson, White, Saline, Perry, Jefferson, Jackson, Hamilton and Franklin Counties. This facility draws water from Rend Lake through one surface water intake (IEPA #70290). The supply provides approximately 15 million gallons per day to 67 satellite supplies with an estimated population of 173,000 persons. Illinois EPA considers all surface water sources of public water supply to be susceptible to potential pollution problems. Hence the reason for mandatory treatment of all public water supplies in Illinois. Mandatory treatment includes coagulation, sedimentation, filtration and disinfection. Primary sources of pollution in Illinois lakes can include agricultural runoff, land disposal (septic systems) and shoreline erosion. Our surface supply location is INTAKE (70290) REND LAKE SURFACE. We want our valued customers to be informed about their water quality. If you would like to learn more, please feel welcome to attend any of our regularly scheduled meetings. These meetings are on the 4th Monday of each month at our administration office located at 1231 Marcum Branch Rd., Benton, IL. The source water assessment for our supply has been completed by the Illinois EPA.
