The new process would save the Water and Sewer Departments approximately \$2,000.00 annually. The current envelope stuffer is old and currently requiring a lot of expensive repairs. Commissioner Webb made a motion to approve the purchase of the InfoSend billing process. Commissioner Goss seconded the motion.
