
**WHEREAS**, the City finds it necessary, on occasion to amend and update sections of the Marion City Code; and


**NOW THEREFORE BE IT ORDAINED**, by the City Council of the City of Marion, Illinois;

**SECTION A:** Regular Council Meetings: The regular meetings of the city council shall be held at the council chambers on the second and fourth Monday evenings of each month in the year. The time of holding said meetings shall be ~~six thirty o'clock (6:30)~~ **five thirty o'clock (5:30)** P.M.; provided, however, that if any such regular meeting falls upon any holiday, recognized as such by either the laws of the United States or the laws of the state of Illinois, then said regular meeting so falling on said holiday shall be held the day following at the time and place aforesaid.
