PLEASE BE ADVISED, pursuant to 415 ILCS 61/10, the City of Marion intends to apply pesticides, including pesticides intended to control weeds and brush, to the public rights-of-way that are located within the corporate boundaries of the municipality.

- Within the Corporate Boundaries of the City of Marion, beginning May 1, 2025, through October 31, 2025, between the hours of 6:30 a.m. and 5:30 p.m. the City may apply pesticide for the control of weeds and brush and other noxious vegetation, when weather permits.
- The brand name of one of the pesticides used is Aqua Neat by Nufarm Americans, Inc., Aquatic Herbicide, for use on Aquatic weeds and brush in aquatic sites, forestry, pastures, rangelands, rights-of-way, habitat restoration areas and non-crop sites.
  - a. Active Ingredient is Glyphosate, N-(phosphonomethyl) glycine, in the form of its isopropylamine salt.
- The brand name of the other pesticide used is Interline<sup>®</sup> Herbicide by UPL NA, Inc., a non-selective herbicide for use on weeds.
  - a. Active ingredient is Glufosinate-ammonium.
